




## **Pay Equity and Transparency**

#### Overview

Pay equity and transparency issues are of increasing concern to employers and employees alike, and with good reason. Just about every state in the country has passed legislation to complement the Equal Pay Act mandating equal pay for equal work and most states have pay equity and transparency laws that are more far-reaching than federal law. Many states, including California, New York and New Jersey, have enacted robust pay equality statutes covering all protected classes of employees and other states like Massachusetts, Colorado and Oregon have unique safe-harbor provisions for employers who conduct pay equity audits.

High stakes equal pay litigation has exploded across industries and multi-million-dollar class action settlements are reported weekly. Activist shareholder groups are demanding that companies conduct pay audits to ensure employees are being paid fairly and are complying with these new laws.


#### **Representative Work**

- A technology company reviewing its workforce for gender and race/ethnicity learned that it had
  no statistically significant adverse impact for any of the groupings evaluated, but that a few of its
  individual employees' compensation reflected that they were outliers whose predicted and actual
  salaries were not in line. As a result, the company needed to review only a handful of individuals,
  rather than focus on a large-scale correction.
- We conducted a pay equity audit where we learned that only one of the company's regional
  manufacturing locations had statistically significant adverse impact, which was sufficiently
  severe that it was impacting the overall results. Identifying and narrowing the focus allowed the
  company to resolve the disparity on a smaller, more manageable scale and to position itself well
  to take advantage of a state safe-harbor provision, if need arises.
