Employees and visitors are welcomed into an inviting reception area that opens onto a large patio overlooking a tree-lined atrium just steps away.

The location is a pedestrian-friendly walkable neighborhood with easy-access to more than 80 restaurants and upscale retail options. It is walking distance to downtown and the Arts District with convenient access to Klyde Warren Park and Katy Trail. There is plentiful parking available with convenient freeway access to the Dallas North Tollway and Woodall Rodgers Freeway, allowing quick access to I-35 and I-30 to the west and North Central Expressway and I-45 to the east.
