Prior to his in-house role, Chris was with a Nashville law firm where he handled white collar criminal defense and represented clients in complex civil and parallel-track (civil and potential criminal) cases in state and federal courts. In this role, he also conducted and managed internal corporate investigations and advised clients on corporate executive risk exposure and compliance issues. Chris has substantial experience and a proven track record as a leader in business operations for a number of companies prior to practicing law.

Earlier in his legal career, Chris established his own law practice with a strong focus on trials and litigation. He then went on to serve as Assistant General Counsel in the Tennessee Department of Commerce & Insurance before becoming an Assistant District Attorney in Tennessee's 19<sup>th</sup> Judicial District. Chris also served as an Adjunct Professor at Vanderbilt University Law School where he taught pretrial litigation.

Chris earned his J.D. from Vanderbilt University Law School where he was the president and founder of Law Students for Veteran's Affairs and an active member of the moot court and mock trial teams. Chris proudly served as a member of the U.S. Coast Guard in various leadership positions for over a decade. He is admitted to practice in all Tennessee state and federal district courts as well as the Supreme Court of the United States.
