## **SB 1343 Employee Anti-Harassment Train-the-Trainer**

**\*\*Participants of the Employee “Train-the-Trainer” Session are required to attend the Supervisor Training from 9:00 a.m. – 11:00 a.m. on Tuesday March 18, 2025.**

SB 1343 extends the AB 1825 training mandate to include all employers with five or more employees, requiring anti-harassment training for nonsupervisory staff. It requires that all nonsupervisory employees must complete one hour of anti-harassment training. All employees' training must occur within six months of hire, followed by every two years thereafter.

This session is exclusively designed for qualified human resources professionals, equipping them with the knowledge, confidence, and resources to conduct SB 1343 compliant training within their organizations.

Training materials will be provided in both English and Spanish.

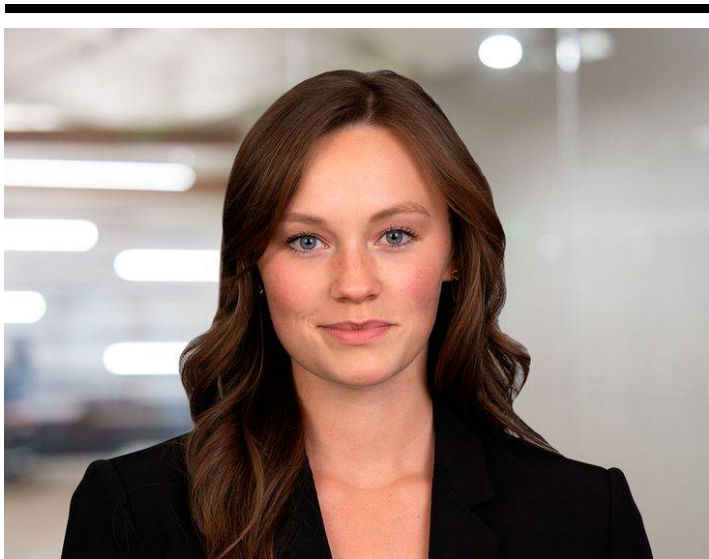

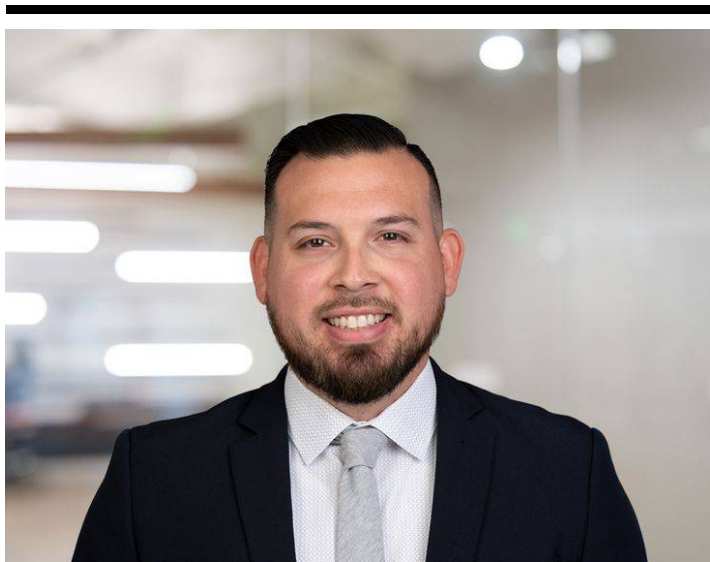

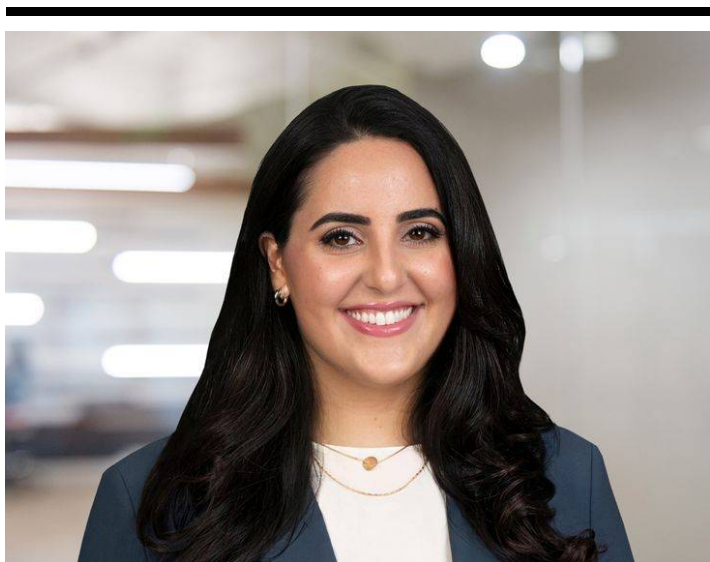
